Gloucester County College will host the next Plant Executives of Gloucester and Salem Counties meeting and I am the keynote speaker. I would like to share with you the "GCC Works For Me" video that I will present at the meeting.

Employee Recognition:

I am proud to inform you that Library Director Jane Crocker was presented with the "New Jersey Library Association Award of Thanks" during a recent NJLA conference. This special award is in recognition of Ms. Crocker's outstanding contributions as chairperson of the NJLA's editorial board and as editor of the NJLA newsletter. Congratulations Jane!

Academic Recognition:

It is a pleasure to report that Gloucester County College has again been recognized as a leader in education and health, physical education and recreation programs and that we have been named a national top associate degree producer by *Community College Week*. This biweekly newspaper for community, technical and junior colleges ranked GCC 9th nationally in the number of associate degrees awarded to education majors and 35th in parks, recreation, leisure and fitness studies. The rankings include four-year institutions that provide associate degrees.

Enrollment:

The final Summer I course enrollments were 17.9% higher than last year, with 1,915 students enrolled (291 additional students), and credit hours increased 21.9%. As of today, Summer II enrollments are 22% ahead of this time last year, with 1,432 students enrolled (314 additional students), and credit hours are 30.5% higher. Fall enrollment is currently at 63.7% of our headcount enrollment goal with 162 additional students registered compared to this time last year.

Professional Appointments:

I am pleased to announce that I have been appointed an honorary member of the Board of Directors of the Gloucester County Minority Coalition. I would like to thank Trustee Virginia Scott for representing Gloucester County College at the Coalition's annual scholarship awards brunch last month.
