President Keating gave a power point report (attached) highlighting enrollment and spoke to retention efforts.

2. Student Government Association Report

Ms. Judith Atkinson, Vice President of Student Services, stated that the Student Services department is very busy advising students and enrolling new students. Mr. Dylan Hughes, SGA President, spoke of the SGA's sponsorship of a "giving tree" project that successfully assisted all families involved. He then introduced Dr. Susan Glenn, Associate Professor of Biology and KotoriCon Chair. Dr. Glenn spoke about the annual anime convention, "Kotoricon 2015", that was recently held on campus. She stated that over 120 volunteers worked to make this year's convention a success, and she introduced several of the volunteers. Dr. Glenn thanked the Board for the opportunity to host the convention.

4. Facilities/Property

At the request of Trustee Jean DuBois, Mr. Dominick Burzichelli, Vice President and Chief Operating Officer, gave an update on construction projects. Trustee DuBois then proceeded with the following Facilities/Property items:

 On the recommendation of the President, Ms. DuBois made a motion, seconded by
 Mr. Wills and unanimously passed, to approve entering into a shared services
 agreement with and to award a contract to Educational Information & Resource
 Center for the Adult Center for Transition data wiring in the amount of \$90,247.00.
- b. Utility Easement: Atlantic City Electric

On the recommendation of the President, Ms. DuBois made a motion, seconded by Mr. Daws and unanimously passed, to approve a utility easement to Atlantic City Electric to provide the electrical transmission from an existing junction box located on properties owned by RCGC for irrigation pumps located on the athletic fields of Gloucester Catholic High School for the monetary fee of \$1.00.

c. Contract Award: NetCarrier Telecom

On the recommendation of the President, Ms. DuBois made a motion, seconded by Dr. Lavender and unanimously passed, to award a contract to NetCarrier Telecom for voice services at an estimated annual amount of \$51,663.36.

The National Perspective

If you have been skeptical about American demographic changes and the resulting decline in college enrollment, review the latest United States Census Bureau statistics. Released Sept. 24, 2014, the report shows a historic drop in college enrollments:

- A one-year decline of more than 460,000 students
- A two-year decline in enrollment of 930,000 students, called "larger than any college enrollment drop before the recent recession"

Two-year institutions are affected most: Enrollment dropped 10 percent at two-year colleges, while it rose modestly (1 percent) at four-year institutions.



RESOLUTION TO APPROVE AND AUTHORIZE THE EXECUTION OF A UTILITY EASEMENT AGREEMENT BETWEEN ROWAN COLLEGE AT GLOUCESTER COUNTY AND ATLANTIC CITY ELECTRIC COMPANY IN CONNECTION WITH UNDERGROUND ELECTRICAL FACILITIES FOR GLOUCESTER CATHOLIC HIGH SCHOOL ATHLETIC FIELDS

WHEREAS, Rowan College at Gloucester County the Board of Trustees (the "Board") of Rowan College at Gloucester County ("Rowan") approved a project consisting of an underground electrical facility for Gloucester Catholic High School athletic fields; and

WHEREAS, in order to provide electrical service to the athletic fields owned by Gloucester Catholic High School, Rowan has entered into an agreement with Atlantic City Electric to install certain electrical transmission from a junction box located on property owned by Rowan College at Gloucester County; and

WHEREAS, after installation, Atlantic City Electric will be responsible for maintenance and repair of such electrical facilities; and

WHEREAS, in order to construct and maintain such electrical transmission facilities, Atlantic City Electric requires an easement through lands owned by Rowan; and

WHEREAS, the Board has determined that the easement requested by Atlantic City Electric will not infringe upon any Rowan interest in real property necessary for college purposes; and

WHEREAS, the Board has determined that the grant of the requested Atlantic City Electric easement is necessary for the completion of the project; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Rowan College at Gloucester County hereby authorizes and directs the Authorized Agent as defined herein is authorized to execute the Utility Easement Agreement between Rowan College at Gloucester County and Atlantic City Electric Company in a form substantially consist with the Utility Easement Agreement attached hereto.

BE IT FURTHER RESOLVED that said resolution is being made in accordance with all applicable New Jersey Statutes and Codes.
