STUDENT AND ATHLETIC RECOGNITION

President Keating introduced Mr. Brian Rowan, Executive Director of Athletics. Mr. Rowan introduced student athletes Katherine Dunne, Tyler Ellis, Mike Colville, MacKenzie Lafferty and Victoria Flynn. They each spoke about their academic plans and of their participation in national championship events. Mr. Rowan then proudly announced that the Roadrunners of Rowan College at Gloucester County received the 2016-2017 "Collegiate Athletic Administrators of New Jersey Cup for Overall Athletic Program Excellence" in the New Jersey Two-Year College Sector. This is the 12th consecutive year that the athletic program has won this prestigious award, and it is the 16th time overall.

PRESIDENT'S REPORT

Mr. Copsetta spoke about his RCGC experience and plans and then showed the "Graduating College Before High School" video that he created in which he encourages high school students to take advantage of the RCGC High School Options Program to earn college credits while in high school and save time and money.

FINANCE

On the recommendation of the President, Trustee Ruby Love made a motion, seconded by Trustee DuBois and unanimously passed, to approve the revised fiscal year 2018 tuition and fee schedule as presented. (Resolution attached)

FACILITIES/PROPERTY

At the request of Trustee Doug Wills, Mr. Burzichelli gave an update on the College's construction projects and provided an overview of the "Eds and Meds" redevelopment RFP. He then introduced Mr. David Weinstein, Esq., who provided information related to the legal steps of the redevelopment project.

On the recommendation of the President, Trustee Wills made a motion, seconded by Trustee DuBois and unanimously passed, to approve:

- 1. Shared services agreement with Gloucester County Improvement Authority related to the redevelopment of certain real property;
- 2. Contract awards to:
 - a. Ampro for athletic supplies and equipment;
 - b. Ogren Construction for the installation of door and window frames, glazing and doors;
 - c. Allied Account Services for external collections services;
 - d. Constellation Energy for the supply and delivery of electricity; and
 - e. Jones Turf Management for athletic field turf management.

Mr. Burzichelli provided an update on the meeting of the Building Naming Committee that met today to discuss naming options in recognition of a \$500,000.00 donation from the Give Something Back Foundation to the College Foundation.

At the request of Trustee James Lavender, Dr. Linda Hurlburt, Vice President of Academic Services, gave an update on happenings in the Academic division. She stated that our Associate Degree Nursing program, which was ranked the #1 Nursing Program in New Jersey for 2017, was recently granted a full eight year accreditation by the Accreditation Commission for Education in Nursing.

- 4. Resolutions to apply for and upon award, accept funding from the Department of Human Services for the RSVP Senior Corps Medicare Improvements for Patients and Providers Act grant;
- 5. Resolutions to apply for and upon award, accept funding from the Gloucester County Division of Senior Services for the RSVP Senior Corps Friendly Visitor and Wellness Education grants.

Notes

- (1) Out-of-county residents must apply for a Certificate of Residence (charge-back) from their home county as required by State statute 18A:64A-23 and 18A:64B-4.
- (2) The NJVCC on-line course fee is an estimate for informational purposes only. The actual rate is set by the Council of County Colleges.
- (3) Processing and administering of all standardized tests are charged for the actual cost to purchase the test (approximately \$30 to \$50 per test) plus a \$25 fee to administer the test.
 - Lexis-Nexis subscriptions are charged to the student at the actual cost of the subscription. This cost is currently \$40 per year. This subscription is optional for paralegal students who desire off-campus access to Lexis-Nexis.
- (4) These services are included as part of the General Service Fee.
- (5) Liability insurance is mandated for all Nursing and Allied Health students. The \$50 assessment is a current estimate. The actual fee will reflect the actual pass-through cost of insurance.
- (6) Annual Library membership fee applies to Non-Student County residents. This fee is waived for residents whose municipal library participates in the LOGIN Consortium. Access to the Library is included in the tuition for all RGCC students.
- (7) These course fees are in accordance with programs listed in the College Catalog.



RESOLUTION OF THE ROWAN COLLEGE AT GLOUCESTER COUNTY BOARD OF TRUSTEES AUTHORIZING A CERTAIN SHARED SERVICES AGREEMENT BY AND BETWEEN ROWAN COLLEGE AT GLOUCESTER COUNTY AND GLOUCESTER COUNTY IMPROVEMENT AUTHORITY GLOUCESTER PURSUANT TO WHICH COUNTY IMPROVEMENT AUTHORITY SHALL PROVIDE CERTAIN SERVICES TO ROWAN COLLEGE AT GLOUCESTER COUNTY RELATED TO THE REDEVELOPEMENT OF CERTAIN REAL PROPERTY AND AUTHORIZING OFFICERS OF ROWAN COLLEGE AT GLOUCESTER COUNTY TO TAKE ALL OTHER ACTIONS DEEMED NECESSARY OR DESIRABLE IN CONNECTION WITH THE SHARED SERVICES AGREEMENT.

WHEREAS, the Board of Trustees (hereinafter the "Board") of Rowan College at Gloucester County (hereinafter the "College"), a body corporate in the State of New Jersey, is authorized to enter into contracts and agreements under and pursuant to N.J.S.A. 18A:64A-1 et seq.; and

WHEREAS, the College owns a parcel of land located in the Township of Deptford (the "Township"), County of Gloucester, New Jersey, designated as Block 417, portion of Lot 1, consisting of 43.78 acres located on the College Campus (hereinafter the "Parcel"), which the Township has declared as an area in need of redevelopment, as defined under N.J.S.A. 40A-12A-1; and

WHEREAS, the College seeks to enter into a Shared Services Agreement (the "Agreement") with the Gloucester County Improvement Authority ("the "GCIA"), pursuant to which GCIA shall provide certain services to the College with regard to the solicitation of third parties to provide services necessary to the redevelopment of the Parcel as well as assist in administration of such redevelopment; and

WHEREAS, the College desires to accomplish the goals and objectives as set forth in the Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Rowan College at Gloucester County as follows:

- 1. The Board hereby authorizes, approves and consents to the execution of the Agreement, and further authorizes the Chairperson of the Board, the Secretary of the Board, the President of the College, the Vice President of the College, and Chief Financial Officer and any other representative of the Board hereafter duly authorized by the Board in writing (the "Authorized Officers" and each an "Authorized Officer") to determine all matters and authorize all necessary actions in connection therewith.
- 2. All resolutions, orders and other actions of the College in conflict with the provisions of this resolution to the extent of such conflict are hereby superseded, repealed or revoked.
- 3. All actions heretofore taken and documents prepared or executed by or on behalf of the College by its officials and by the College's professional advisors, in connection with the Agreement or the redevelopment of the Parcel, or any other action in connection with or related to the same, are hereby ratified, confirmed, approved and adopted.

This resolution shall take effect immediately.

RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR TURF MANAGEMENT OF THE CAMPUS ATHLETIC FIELDS (Pursuant to N.J.S.A. 19:44A-20.4 – Non-Fair and Open Process)

WHEREAS, Rowan College at Gloucester County is in need of a turf management accompany for the campus athletic fields; and

WHEREAS, County Contract Law (18A:64A-25.3) does not require public advertising if the purchases do not exceed \$35,300; and

WHEREAS, the College solicited three (3) quotes for a turf management company for the campus athletic fields; and

WHEREAS, the Vice President and Chief Operating Officer has determined that the total value of contract will exceed \$17,500; and

WHEREAS, the New Jersey Local Unit Pay to Play Law, N.J.S.A. 19:44A-20.4, *et seq* provides that when the values of a contract with a vendor exceeds \$17,500, that vendor is subject to the Pay-to-Play law; and
