# RESOLUTION TO ESTABLISH A JOINTURE AGREEMENT FOR ROWAN COLLEGE OF SOUTH JERSEY TO SERVE GLOUCESTER AND CUMBERLAND COUNTIES

**WHEREAS**, the Board of Trustees of Rowan College at Gloucester County on May 25, 2018 passed a resolution authorizing the establishment of a jointure college to serve Gloucester and Cumberland Counties upon the conditional closing of Cumberland County College; and

WHEREAS, the Rowan College at Gloucester County Board of Trustees has determined that it is in the best interest of the students and the community it serves to explore a merger with Cumberland County College; and

**WHEREAS**, the Rowan College at Gloucester County Board of Trustees is desirous of entering into the annexed conditional Jointure Agreement to facilitate the exploration of the subject merger;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Trustees of Rowan College at Gloucester County does hereby authorize its Chairperson to enter into the attached conditional Jointure Agreement.

AND IT IS FURTHER RESOLVED that the Officers of Rowan College at Gloucester County are authorized to execute any and all documents and to take any and all necessary action in furtherance of the implementation of the Jointure Agreement approved hereby, subject to the ultimate decision of the Trustees as set forth in Section 2 thereof.
