### *Rights and Responsibilities*

- Only courses that are required for the student’s program of study (major) will be covered by financial aid.
- RCSJ can only pay federal and state aid, including student loan programs, for one retake of a previously passed course.
- If I plan to withdraw and/or drop from courses, I must contact my academic advisor and the Office of Financial Aid.
- I understand that financial aid cannot pay for any courses that are designated as Audit.
- I understand that if I never attend, stop attending or receive any combination of negative grade statuses (I, F, W, X, NP and/or NA) for classes, the Office of Financial Aid is required to determine any withdrawal calculations to my financial aid awards.
- I will not receive a Federal Pell Grant from more than one college for the same period of time.
- I will notify RCSJ if I become delinquent or default on a federal student loan.
- Students are not required to be full time to receive financial aid, however some programs require specific enrollment and credit levels. Federal Student loans require a minimum of six (6) credits to be eligible for disbursement.
- Refund checks are mailed to students. RCSJ does not release financial aid refunds to students prior to the scheduled timeframes. Students are encouraged to plan and budget for all incurred educational and non-educational related expenses they may encounter while enrolled as an RCSJ student.
- I certify that I will use any Federal Title IV and Higher Education Act funds I receive during the award year for expenses at Rowan College of South Jersey (RCSJ). Any violations of the governing financial aid regulations could result in the termination of my financial aid. Cases of suspected fraud or other criminal misconduct will be referred to the Office of the Inspector General of the U.S. Department of Education.
- Regardless of whether or not a student receives any form of financial aid (NJ STAR scholarship, grants, loans, other scholarships and/or tuition waivers), the student must understand that they are held personally responsible for all financial charges that they accrue at RCSJ. The College may permit any student to register before determining a student’s eligibility for the federal or state grants, loans, scholarships or tuition waivers. If, for any reason, a student should become ineligible for federal and/or state grants, loans, scholarships, tuition waivers or other types of financial aid, the student agrees to pay their account in full including any collection and/or attorney’s fees that may be incurred by or on behalf of the College to satisfy the student’s financial obligations.
- In order to remain eligible for federal and state financial aid programs, students must continue to meet SAP requirements. Eligibility requirements for assistance from the federal and state financial aid programs are contingent on students’ meeting the minimum Qualitative (GPA) and Quantitative (pace) standards within a Maximum Time Frame (150%). If you are on an academic plan, you are required to follow the terms of the plan and meet the GPA criteria as identified on the plan.
