**Please read each statement and check each box:**

- I understand that I will file a complete Free Application for Federal Student Aid (FAFSA). Failure to do so will result in being ineligible for the use of the Unemployment Tuition Waiver.
- The student will comply with all requests for additional documentation from the Office of Financial Aid. If a student does not comply with all of the above requirements they will be considered INELIGIBLE for the program.
- I understand I must obtain a **Tuition Free Waiver form NJES8 (R1/01)** from my Career Counselor at the Unemployment Office. The **NJES8** must have the term for which it is intended noted on the form by the One-Stop Career Counselor and the courses approved by the career counselor must be listed on the back of the **Tuition Free Waiver form NJES8**.
- I understand I cannot enroll for courses under the Unemployment Free Tuition Waiver until the dates specified by the Office of Financial Aid. These dates vary from term to term but are generally **the day each specific course is scheduled to begin**.
- I understand the program will be honored at Rowan College of South Jersey (RCSJ) by applicants that reside in Gloucester or Cumberland County. (*Out-of-County students are required to apply to their home county college and provide proof of their application to their home county school prior to having the waiver applied to their account.*)
- I certify that I am **not defaulted** or in an **overpayment** status on any federal grants or loans.
- I understand that the waiver will only be applied to those courses specified on their **NJES8 Tuition Free Waiver form**.
- I understand that the waiver will only cover the amount of **Per-Credit Cost of Tuition, General Service Administrative Service and Capital Construction Fee**. I will be responsible for the payment of all other fees associated with the cost of registering for the courses.
- I understand that I cannot pay to reserve a seat in a course and I will not be refunded any money if I paid for courses in advance.
- If for any reason the student is unable to attend the student must drop their courses. The student is not to assume that they will be dropped for non-payment should they stop attending.
- I understand if I need to withdraw from a course, I will complete the proper withdrawing procedure forms with the RCSJ Records Department.
- The student certifies that they must be **ACCEPTED AND MATRICULATED** into a degree seeking program to be eligible for the National Guard Tuition Waiver.
- The student certifies that they are **NOT in DEFAULT or OVERPAYMENT** status on any Federal grants or loans.

Regardless of whether or not the student receives financial aid and/or the Unemployment Tuition Waiver, the student will be **PERSONALLY RESPONSIBLE** for all financial charges that they have incurred at Rowan College of South Jersey. RCSJ may permit students to register before a determination is made regarding their eligibility for financial aid or tuition waivers. If a student has or becomes ineligible for any form of financial assistance (including grants, loans, scholarships and/or tuition waivers) students shall agree to pay their account in full including any collection and/or attorney's fees that may be incurred by or on behalf of the College to satisfy their personal financial obligations to the school.

By signing this form, the student agrees to all of the above statements. The student also confirms that all information and supporting documentation collected from them is true, accurate and complete to the best of their knowledge.
