This course is an introduction to techniques using computer-based music recording and multimedia software found on the Macintosh platform, principally GarageBand, iPhoto, iMovie. This course is designed to give the aspiring student a sound pedagogical foundation in the theory and application of computer-based music and multi-media technologies. Also, this course covers foundations, practices, and creative techniques in audio recording and music production, including microphone selection and placement, mixing, mastering, signal processing, automation, and digital audio workstations.
