Students analyze the components of motion pictures including color, lighting, editing, scripting, directing and acting.

- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
