CG 212: Screen Graphics

Syllabus

Lecture Hours/Lab Hours/Credits: 2/2/3

Catalog Description

Prerequisite: CG 103

This course provides instruction on methods of creating graphics for use in web page(s), website design, game design and/or mobile screen design. Students will be introduced to principles of interactive design concepts. Concepts include the issues of resolutions, vector vs. raster graphics, correct use of type and color, and creation of graphics used in animations for the screen and web. All lecture topics are supported by a lab component.

- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- **10. Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.

- To develop, web page/site layouts including navigation utilizing industry standard user interface design principles
- To demonstrate the knowledge and understanding on how to take a full web page layout/design and to slice the files and export files to be used in a Web Development software program
- To correctly size photos for thumbnail and larger sizes to be placed on a web page or into a game design.
- To create graphics for different screen sizes and devices
