CS 222: Intro to Android Programming in JAVA

Syllabus

Lecture Hours/Credits: 4/4

Catalog Description

This course will introduce beginner and intermediate Java programming students to the development of applications for Android devices such as cell phones and tablet computers. Students will use an Integrated Development environment such as the Android Studio to develop simple java applications. The class will explore a variety of development strategies, then explore concepts in hands-on laboratory sessions Each student will complete an application development project independently using a mix of Android services and features.

Prerequisites: CS 112 or permission of instructor
