# **Catalog Description**

Prerequisites: EL 020 Listening & Speaking 2 (or appropriate score on placement assessment)

This High-Intermediate level course builds upon the listening and speaking skills presented in EL 020. Students practice accurately pronouncing English words, using various spoken expressions and phrases, discussing main ideas in conversations, using "tag" questions to ask for information, and inferring meaning from spoken context clues.
