Topical Outline

Students spend the first several weeks of the course documenting a historic structure through field measurements. The field notes are then taken to the CAD lab and converted into AutoCAD drawings. The drawings are then compared with the existing structure for representative accuracy. The final product is a full set of AutoCAD drawings which comply with HABS standards (i.e. accurate to within ¼ inch) and which include floor plans, elevations, crosssections, and details. The drawings are submitted to the HABS record and archived in the Library of Congress
