#### **Catalog Description**

Prerequisites: EN 102

EN 201 is a survey course of English/British literature from the Medieval Period through the Period of the Restoration and the 18<sup>th</sup> Century. Since the purpose of a survey course is to study those authors contributing the most significantly in the widest possible range, the focus in this course is on the major authors of each period.

- 8. **Global and Cultural Awareness:** Students will understand the importance of a global perspective and culturally diverse peoples.
- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.

## **Topical Outline**

- Unit 1: introduction to Shakespearian theatre and a critical analysis of one of Shakespeare's plays (that will be the basis for the long writing assignment for the semester);
- Unit 2: introductory discussion of the Old English Period and a critical discussion of Beowulf;
- Unit 3: introductory discussion of the Medieval Period and the England of Chaucer; a critical discussion of Everyman and of "The General Prologue: to The Canterbury Tales; explication #1; project thesis card;
- Unit 4: introductory discussion of the 16<sup>th</sup> Century and the Age of the Sonnet; critical discussion of sonnets by Surrey, Sidney, Spenser, Shakespeare;
- Unit 5: introductory discussion of the 17<sup>th</sup> Century; critical discussion of the Cavalier poets (Johnson, Herrick), Marvell, the Metaphysical poets (Donne, Herbert); explication #2; project tentative outline;
- Unit 6: Milton; discussion of the Restoration and the 18<sup>th</sup> Century; critical discussion of Swift, Pope, Johnson; project paper, explication #3.
