**EN 206: Masterpieces in Western Literature II** 

Lecture Hours/Credits: 3/3

### **Catalog Description**

Prerequisites: EN 102

Masterpieces of Western Literature II is a literature survey course designed to introduce students to major works in Western literature from the time of the Enlightenment to the twenty-first century. The course examines each work in terms of the historical context in which it was written and attempts to assess its impact on its contemporary historical period as well as the subsequent development of Western institutions and civilization. Students are afforded an opportunity to examine each work in terms of its literary and historical significance. Such assessments are made through oral discussion of the works in class and written analyses in required papers.

- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
