This course follows the curriculum of the insurance industry's professional certification organization *The Institutes* and, as such, qualifies students to take their examination. The following topics are covered: introduction to risk financing; estimating hazard risk and transferring hazard risk through insurance; self-insurance plans; retrospective rating plans; reinsurance; captive insurance; contractual risk transfer and transferring financial risk; transferring hazard risk to the capital markets; and allocating costs of managing hazard risk.
