CJ 300 Critical Infrastructure

Syllabus

Lecture Hours/Credits: 3/3

Catalog Description

Prerequisite: CJ 222

This course introduces student to the methods and approaches to protecting critical infrastructure a means of effectively protecting people, physical entities, and cyber systems and the establishment of an effective incident command operation. Moreover, students will examine vulnerability rise reduction strategies, contingency planning, and strategic partnership models as they are applied to the critical infrastructure sectors. Course topics include risk assessment and management, contingency planning, training and exercises, the role of crisis management team, crisis communication, and public and private sector roles and relationships in emergency management.

- **8. Global and Cultural Awareness:** Students will understand the importance of a global perspective and culturally diverse peoples.
- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- **10. Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
