### MU 103 Music Theory I

Lecture Hours/Credits: 2/2

## **Catalog Description**

#### Prerequisites: MU 102 Fundamentals of Music

This course is an introduction to the vertical and linear dimensions of tonal music. After a review of musical fundamentals, in which students will be expected to demonstrate facility and speed in naming and spelling basic tonal materials, the course will introduce traditional contrapuntal exercises, basic diatonic harmony, form, analysis, and composition.

- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
