## **Catalog Description**

#### Prerequisites RD 100, EN 060

The purpose of this course is to acquaint the student with the basic principles and functions of government at the state and local level with special attention to New Jersey's state, county, and local government structure and function. The course will examine Federalism, political parties and elections, and the three branches of government in the context of New Jersey politics. Students will be encouraged to develop a critical and analytical approach to political issues and public policy.

- 7. **Historical Perspective:** Students will understand historical events and movements in World, Western, non-Western or American societies and assess their subsequent significance.
- 8. **Global and Cultural Awareness:** Students will understand the importance of a global perspective and culturally diverse peoples.
- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
