The course will explore traditional and modern scenic construction techniques, as well as hands on use of basic woodworking, lighting, and audio equipment. Classes consist of lectures and lab demonstrations.

- 8. **Global and Cultural Awareness:** Students will understand the importance of a global perspective and culturally diverse peoples.
- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
