Acting III is a continuation and extension of first-year work, with particular emphasis on characterization, text analysis, and advanced scene study. Acting techniques are applied to more complex dramatic forms, including genres in which language and characterization are particularly demanding. Theatre periods and style skills are developed which may include some or all of the following: Greek, Restoration and 19th Century playwrights.
