Color exercises and creative assignments are supplemented by lecture, group discussion, critique, and individual instruction.

#### **Assignment instructions and Grading Rubrics**

#### **Criteria for Submitting Artwork:**

- 1. All artwork must be submitted on Bristol Board; in the dimensions given for the assignment.
- 2. Students' names should be written, in pencil, on the back side of the artwork in the bottom right hand corner of the page, along with the date completed.
- 3. Artwork that has been rolled, torn, spilled on and/or damaged will not be accepted. Respect your art.

### **Criteria for Submitting Written Assignments:**

- 4. All essays must be word-processed, double-spaced, on one side of standard-sized paper (8.5 x 11 inches) with top/bottom margins of 1 inch and left/right margins of 1.25 inches.
- 5. A title page is unnecessary. Instead, provide the MLA four-line, double-spaced header in the top left corner of the first page. This header includes the student's name, instructor's name, course number and section, and the date submitted. Then, on this first page, center the title below the header, and begin the essay below the title.
- 6. Pages must be numbered consecutively in the upper right corner, one-half inch from the top and flush with the right margin.
- 7. The Works Cited begins on a separate page, the last page, and is labeled Works Cited centered at the top of the page. Double-space within and between entries.

#### In-Class Work, Participation and Artwork Rubric:

- **A:** Arrives fully prepared at almost every session; plays an active, ongoing role in discussions; comments advance the level and depth of the discussion.
  - Proiects will:
    - Have a strong design, imagination
    - Be innovative
    - Shows excellent technical execution
    - Shows thorough comprehension of media
    - o Demonstrates an ability to go beyond the basics
- **B:** Arrives mostly, if not fully, prepared; participates constructively in discussions; makes relevant comments based on the assigned material.

- Projects will:
  - Demonstrate good design
  - Shows creativity
  - o Is technically well executed
  - Shows substantial progress
- **C:** Preparation is inconsistent; when prepared, participates constructively; when prepared, makes relevant comments based on the assigned material.
  - · Projects will:
    - Fulfill assignment requirements, but does not show substantial exploration of design possibilities
    - Shows limited technique and skill
    - o Was not taken as far as possible or is not finished
- **D:** Infrequently prepared and infrequently participates; comments are generally vague; demonstrates a noticeable lack of interest; negatively impacts discussion.
  - · Projects will:
    - Weak design
    - Weak concept
    - o Inadequate technique and skill
    - Unfinished projects
    - o Does not fulfill the basic requirements of the assignment
- **F:** Rarely, if ever, prepared; rarely, if ever, participates; demonstrates a noticeable lack of interest; negatively impacts discussion.
  - Projects will:
    - Shows evidence of plagiarism
    - o Projects are not completed by the end of the semester
