- I understand that I will file a complete Free Application for Federal Student Aid (FAFSA). Failure to do so will result in being ineligible for the use of the Unemployment Tuition Waiver.
- I understand I will comply with all requests for additional documentation from the Office of Financial Aid.
- I understand I must obtain a **Tuition Free Waiver form NJES8 (RI/01)** from my Career Counselor at the Unemployment Office. The **NJES8** must have the term for which it is intended noted on the form by the One-Stop Career Counselor and the courses approved by the career counselor must be listed on the back of the **Tuition Free Waiver form NJES8**.
- I understand I cannot enroll for courses under the Unemployment Free Tuition Waiver until the dates specified by the Office of Financial Aid. These dates vary from term to term, but are generally **the day each specific course is scheduled to begin**.
- I understand the program will be honored at Rowan College of South Jersey (RCSJ) by applicants that reside in Cumberland County. (*Out-of-County students are required to apply to their home county college and provide proof of their application to their home county school prior to having the waiver applied to their account.*)
- I certify that I am **not defaulted** or in an **overpayment** status on any federal grants or loans.
- I understand that the waiver will only be applied to those courses specified on their **NJES8 Tuition Free Waiver form**.
- I understand that the waiver will only cover the amount of **Per-Credit Cost of Tuition, General Service and Capital Construction Fee**. I will be responsible for the payment of all other fees associated with the cost of registering for the courses.
- I understand that I cannot pay to reserve a seat in a course and I will not be refunded any money if I paid for courses in advance.
- I understand that I will drop my courses, if for any reason I am unable to attend.
- I understand if I need to withdraw from a course, I will complete the proper withdrawing procedure forms with the RCSJ Records Department.

Regardless of whether or not students receive any form of financial aid or the Unemployment Tuition Waiver, students understand that they are responsible for all financial charges that they have incurred at RCSJ. If students are or become ineligible for any form of financial assistance for any reason, all students shall agree to pay their account in full including any collection and/or attorney's fees that may be incurred by or on behalf of the college.
