Freeholder Liaison Remarks –

Freeholder Deputy Director Ms. Darlene Barber was present. Ms. Barber wished the mothers and grandmothers on the Board Happy Mother's Day. Ms. Barber reported John Gibbs, a former longtime English professor at the College, passed away recently. She commented she was a former student of his class and his celebration of life ceremony was very nice. Furthermore, Ms.

Barber wished to congratulate the graduates of the College's class of 2019.

Campus Reports –

Ms. Kellie Slade (Executive Director, Student Services) gave the PowerPoint presentation on the official Graduation Profile Report.

She reported there were 660 graduate petitioners and 794 total degrees earned. She stated a majority of the students (231 students) were graduating with an associate in science. She reported an increase in female graduates (464 female students) and a decrease in male students (196 male students). She reported a majority of the graduating students reported they were Caucasian (304 students) and a minority of students reported they were Hawaiian/Pacific Islander (2 students). She reported this spring the youngest graduating student is 18 years of age and the oldest graduating student is 68 years of age. She reported during the graduation of 2018 the oldest graduating student was 82 years of age. She reported the top two curricula of the graduating class were Biological Science and Nursing. She reported Nursing and Justice Studies changed spots for this year's graduating class. She commented 181 students were Honor Societies students and 116 students were dual credit students. She stated the 116 dual credit students were enrolled before the Early College High School program began. She reported 7 students utilized the Completion Scholarship program. She reported the following employees and employee's family members would be graduating this spring in the commencement: Melissa Anglero, Zuleika D'Emilio, Andrea Enders, LaToya Gibbons, Trinee Parson, Jillian Pierce, Aida Torres, Iris Torres, Yajaira Montero, Diana Appel, Linda Scully, and Iris Torres. She reported there would be a total of 209 students graduating from the University Center. She reported the highest number of students (162 students) would be graduating from Wilmington University. She reported the following Professor of the Year and Academic Advisor of the Year Finalists received an award last night in a special ceremony: Dr. Kate Felice, Professor Kelly Master, Dr. Mark Randa, Diana Appel, Randall Kates, and Meredith Vicente.

Ms. Slade reported the commencement tent and chairs are set up for the upcoming event. She reported the College's 2019 University Center Commencement Ceremony would take place Thursday, May 16, 2019 at 11:00 A.M. She reported the College's 2019 52nd Annual Commencement Ceremony would take place on Thursday, May 16, 2019 at 6:00 P.M. She commented if severe weather was to occur on commencement day then two separate ceremonies based on majors would be held on Thursday May 16, 2019 indoors at the College. The first ceremony would be held at 4:00 P.M. and another ceremony would be held at 7:00 P.M.
