### **Catalog Description**

*Prerequisites: IT 211 or permission of the instructor*

CADD III emphasizes advanced CADD drawings, 3-D solid models, and rendering which incorporates a capstone project. This course promotes self-paced learning and synthesis of skills previously applied in CADD I and CADD II. Students will demonstrate mastery and proficiency in Computer Aided Drafting & Design techniques.

9. **Ethical Reasoning and Action:** Students will understand ethical issues and situations.
10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
