Class instruction focuses on the fundamentals of correct breathing, tone production and diction. This course demonstrates singing/acting techniques through practical application and repertoire study. Topical Outline

This class is a collaborative workshop. In the first week, everyone will bring a song to sing for the class in order to break the ice and foster ideas about song assignments. Week 2 will be spent shopping songs and choosing one for each person to work into our final project. This course will incorporate the following:

- *Group warmup*; getting our bodies and voices warm, and reminding everyone of the basics of singing.
- *Individual song work*; working on each song both from a technical standpoint and dramatically, discussing character, story, and presentation.
- *Class interaction*; using acting exercises to help each singer tell the story, involving other class members.
- *Group discussion*; as the individual songs take shape, the class will interpret varying ways in which these songs might be performed. We will then begin to create a show -deciding on the order of songs, possible themes, common threads among songs, and staging - using ideas that may emerge from the class interaction above.
- *Rehearsal of final project*; once the show is created, the final weeks will be geared towards running it from start to finish, finding a flow and pacing, and making any necessary changes.
